CIRCULAR TO ALL EMPLOYERS

TUESDAY 27TH DECEMBER 2011

Please be advised that, in terms of the Main Collective Agreement for the Motor Industry (Govt. Gazette No. 34552) Govt. Notice No. R687 dated 26 August 2011, coming into effect on 5 September 2011 and remaining in effect for the period ending 31 August 2013, the following shall apply in respect of Public Holidays declared for the period 24th to 28th December 2011.

Main Collective Agreement, Division A, Clause 9.6: PUBLIC HOLIDAYS

prescribes inter alia that:

- (1) Employees shall be entitled to leave on full pay on all days that are public holidays in terms of section 1, or declared as such under section 2, of the Public Holidays Act, 1994.
- (2) Whenever an employee works on a statutory public holiday in respect of which he is entitled to leave on full pay in terms of sub-clause (1), his employer shall pay him double his hourly rate for each hour or part of an hour worked on such day.

To this end, the Public Holidays dated 25th and 26th December 2011, prescribed in terms of Section 1, and that of 27th December 2011, as declared under Section 2, of the Public Holidays Act 1994, will be applied in the Motor Industry in terms of Clause 9.6 as prescribed.

Please note that the provisions of Clause 9.6 of the Main Collective Agreement shall apply equally to the Public Holidays of 1st and 2nd January 2012.
