NOTICE: ENACTMENT OF THE MIBCO ADMINISTRATIVE COLLECTIVE

**AGREEMENT** 

This serves to confirm that the MIBCO Administrative Collective Agreement (Admin Agreement), Gazette 44190 of 19 February 2021, Notice no.137 has been published and extended to non-parties.

The Government Printing Works (GPW) experienced problems with their system and could not publish gazettes on time nor were they be able to inform the public of gazettes that have been published. The aforementioned gazette was published on 19 February 2021, but only loaded onto the GPW website on 01 March 2021. The notice of the Minister states that the collective agreement comes into effect on the second Monday after the date of publication, which is 01 March 2021. Employers are therefore urged to adjust the MIBCO levy amount to R3.14 (three rand fourteen cents) per week on the MIBCO Online Returns system or contact MIBCO to make the changes before the first return of March is due.

## Please take note of the following:

- The MIBCO levy is the only change from the previous Admin Agreement and the amount increased to R3.14 (three rand fourteen cents) per week, applicable to Employers and Employees respectively;
- All previous Agreements and subsequent extensions have been repealed.
- New applications or re-applications to extend exemptions with respect to the Admin Agreement must be submitted to the MIBCO Regional Councils for consideration (that would typically include processing of bulk returns, etc.). Employers requiring national exemptions for 'groups of companies' should make their submissions to the Regional Council where the head office of those companies reside; and
- The period of operation is effective as of Monday 01 March 2021 and will expire on 31 August 2022.
